# PRE-ARRIVAL CHECKLIST

## 1: Obtain Visa and Passport

- ☐ Make sure your passport is valid for at least six months from the date you plan to enter the U.S.
- ☐ Obtain an I-20 or DS-2019 with a start date for your planned enrollment.
- ☐ Pay the SEVIS I-901 fee.
- ☐ Schedule a visa application interview at a U.S. Embassy or Consulate.

## 2: Get Your Finances in Order

- ☐ Bring enough accessible money for your initial living expenses.
- ☐ Make plans to pay tuition and fees before the deadline.

## 3: Complete Health Tasks

- ☐ Submit your immunization records.
- ☐ Submit health forms.
- ☐ Fulfill the health insurance requirement.
- ☐ Purchase travel insurance to cover you until orientation.

## 4: Required Online Programs

- ☐ Haven: Understanding Sexual Assault Program
- ☐ AlcoholEdu Program (undergraduate students under age 23 only)
- ☐ Create a YOU@CSU profile

## 5: Secure Housing

- ☐ Complete housing application as soon as possible.
- ☐ Arrange for temporary housing, if needed.

## 6: Register for Classes

- ☐ Take the appropriate placement exams (undergraduates)
- ☐ Contact your department for more information (graduates)

## 7: Arrange Transportation

- ☐ Arrive the weekend prior to orientation.
- ☐ Reserve shuttle transportation from Denver International Airport to campus.

# U.S. VISA AND IMMIGRATION-RELATED INFORMATION

For every immigration document you receive, check that the spelling of your name and your date of birth are exactly the same as listed on your passport. Your passport must be valid for six months after your intended entry into the United States. Copy all documents prior to departure. Carry all originals with you when you travel, and keep copies in a separate place.

## OBTAINING A VISA

### 1. Receive I-20 or DS-2019 from CSU

Your I-20 or DS-2019 form should be included in the packet with this pre-arrival guide. You will be required to submit this document when you apply for a visa at a U.S. Embassy or Consulate.

### 2. Pay the SEVIS I-901 fee

At least two weeks before your visa interview, pay this fee online at [fmjfee.com](https://fmjfee.com). Type your name exactly as it appears on the I-20 or DS-2019 form. Print a copy of the online receipt and bring it to your visa interview. (Canadians should present this receipt at the U.S. border.) Make copies of this receipt and keep it with your other immigration documents.

### 3. Complete the DS-160 form

The DS-160 form is a non-immigrant electronic visa application, available on your local U.S. Embassy/Consulate website.

### 4. Pay visa application fee

Follow the instructions on your local U.S. Embassy/Consulate website to pay this fee.

### 5. Make your visa appointment at a U.S.

#### Embassy or Consulate

Find your local U.S. Embassy or Consulate at [usembassy.gov](https://usembassy.gov) and schedule an appointment with them as early as possible. The wait time for a visa interview varies, but is always longer during the months of June, July, and August. Depending on your course of study and nationality, the visa officer may also have to get special clearances, which can require additional time. The earliest the U.S. Embassy or Consulate can issue an F-1 visa is 365 days before the start date of your program in the U.S. If you are applying for a J-1 visa, you may apply any time before the beginning of your program.

### 6. Prepare and bring to your visa interview:

*Remember to remain calm and answer all the visa officer's questions openly and honestly.*

- ☐ Passport valid for at least six months
- ☐ I-20 or DS-2019 form (signed/dated)
- ☐ Admission letter
- ☐ Two 2" x 2" photographs in the required format
- ☐ A receipt of the paid SEVIS I-901 fee
- ☐ Financial evidence of sufficient funds to cover tuition and living expenses during your period of study
- ☐ Any information that proves that you will return to your home country after finishing your studies in the U.S. This may include proof of property, family, or other ties to your community.

### 7. Visa Delays

If you are unable to obtain a visa prior to the program start date, contact ISSS ([iss@colostate.edu](mailto:iss@colostate.edu)) immediately. You may defer and apply your deposit toward the tuition for the next semester.





# ARRIVING IN THE UNITED STATES

## 1. Plan your arrival

You will not be allowed to enter the country more than 30 days before the start of your program if you are an initial entry student. Plan to arrive the weekend before Orientation on Saturday or Sunday.

*Remember: Always carry your original I-20 or DS-2019 and passport on you, not in your luggage!*

## 2. At the port of entry

Proceed to the terminal area for arriving passengers. Present the following documents:

- ☐ Passport
- ☐ SEVIS (I-20 or DS-2019 Form)
- ☐ Customs Declaration Form (CF-6059), which reflects the address where you will reside, not the address of the school or program.

All visitors entering the U.S. must state their reasons for wishing to enter the country. You will be asked to provide information about your final destination. It is important that you tell the Customs and Border Protection (CBP) officer that you will be a student. Be prepared to include the name and address of the school program in which you are enrolled. Also be prepared to demonstrate financial funding if they ask you to show you can afford your schooling.

Once your inspection is successfully completed, the inspecting officer will assign you an Admission Number (I-94). You can locate your I-94 number at [i94.cbp.dhs.gov](https://i94.cbp.dhs.gov). Be sure to check that your I-94 lists the correct visa type (either F or J,) correct date, and D/S for Duration of Status.

## 3. Secondary Inspection Requirements

If the CBP officer at the port of entry cannot initially verify your information or you do not have all of the required documentation, you may be directed to an area known as “secondary inspection.” Here the CBP Officer will attempt to verify your status by using the Student and Exchange and Visitor Information System (SEVIS). In secondary inspection, you can ask for an interpreter from your native language and you may ask why you are in secondary inspection. If the officer needs to verify information with your school or program, contact International Student and Scholar Services at +1 (970) 491-5917.

In case of an after-hours emergency, please contact the Colorado State University Police Department at +1 (970) 491-6425. They will connect you to the on-call ISSS person.

## 4. International Post-Arrival

### Check-in (Immigration Document Review)

All new international students complete an immigration document review after arriving in the United States. You will receive additional information about this process by email. Please make sure you have the required documents:

- ☐ Passport (including the U.S. entry stamp)
- ☐ I-20 or DS-2019 form
- ☐ The name and address of an emergency contact in the U.S. or your home country
- ☐ Current U.S. address and phone number

International Programs requires these documents to register your arrival in the SEVIS system as required by the U.S. government. If a report is not submitted, you may be considered in violation of your immigration status in the U.S. If you cannot complete this process online, please email [ISSS@colostate.edu](mailto:ISSS@colostate.edu) as soon as possible with the documents above. You will not be able to register for classes until this requirement is completed.

# FINANCES

## How much money should I bring?

Bring enough money to cover your expenses during your first few days in the U.S., such as food, transportation, personal items, and temporary housing. These expenses can be covered with major credit cards, debit cards and ATM cards. We don't recommend carrying more than \$1,000 in cash. You can set up a checking account at a local bank once you arrive, and wire money electronically as needed. Calculate the estimated expenses and learn more about tuition and fees for your first year [online](#).

## Tuition and Fees

The best way to pay tuition is through the International Funds option on [RamWeb](#). Tuition and fees will be charged to your RamWeb account each semester, along with any on-campus housing and CSU health insurance charges.

Late fees will be charged if the bill has not been paid in full by the deadline, and a registration hold will be placed on your account to prevent registration for future courses. Students should also budget for textbooks, approximately \$300 to \$600 per semester.

# HEALTH AND INSURANCE

All students are required to complete the following by the first day you arrive. All documents must be created or translated into English. Consult your family members and doctor before leaving to complete the health history, tuberculous screening and immunization records requirement.

- ☐ Immunizations: Submit completed Colorado State University Mandatory Immunizations Form showing proof of the following:
  - ☐ Measles, Mumps and Rubella (MMR)
  - ☐ Meningococcal Vaccinations (for students living on campus)
    - Note:** COVID-19 Vaccines are highly recommended, but are not required for Colorado State University students
- ☐ Submit Health Forms
  - ☐ Health History
  - ☐ Tuberculosis Assessment
  - ☐ Authorization for Treatment of a Minor (if under age 18)
- ☐ Fulfill the Health Insurance Requirement
  - ☐ More information about health insurance coverage and costs can be found at: [col.st/44POy](https://col.st/44POy)
  - ☐ **There may be requirements related to the COVID-19 pandemic, testing, and vaccines with travel. Please see [international.colostate.edu/iss](https://international.colostate.edu/iss) for more information.**

## Waiving Health Insurance:

If you have health insurance and would like to waive the mandatory CSU insurance, you must provide proof that your insurance coverage meets the CSU requirements. Travel insurance policies will not meet the waiver requirement.

## Sponsored Students:

If your sponsor's health insurance coverage is known to meet the waiver requirements, you will not be charged if you show your letter of financial guarantee upon arrival. To see if your alternative insurance



## IMPORTANT INFO

**You must pay for your insurance on your CSU student account upon your arrival at CSU. Make sure you have at least \$1,000 to pay for one semester of insurance.**



# HOUSING AND DINING

## ON-CAMPUS HOUSING

All first year undergraduate students (freshmen) are required to live on campus in the residence halls for their first two semesters. Housing is guaranteed for freshmen students. Transfer students and graduate students are not guaranteed housing, but may apply if they wish to live on campus.

Apply for housing immediately after you receive admission. On and off-campus space fills quickly.

### Residence Halls

There are 15 residence halls on the CSU campus. Most residence hall rooms host two students in one room. Consider living in one of the Residential Learning Communities (RLC) to enhance your academic and social experience.

### Items Included in Your Room

- Adjustable bed frame
- Desk with chair
- Closet
- Curtains
- Trash and Recycle Bins

### Apartments

CSU offers both single and family apartments. Furnished apartments as well as month-to-month leases are available. Aggie Village Apartments are a brand new global community for students interested in an intercultural experience. ### Features of On-Campus Living

- Convenient locations on campus close to classrooms, library and the recreation center.
- Supportive and involved live-in staff
- Securely locked doors on the exterior and interior of the buildings.
- Free high-speed internet and cable TV service.
- Student kitchens, laundry facilities, study rooms, lounges with TVs and games.

## OFF-CAMPUS HOUSING

Off-campus housing is another option available for transfer and graduate students. If you prefer to live off-campus, you should begin your search as soon as possible.

Finding furnished apartments is rare. Plan to pay your first and last month's rent before you move in plus a deposit.

### Signing a Lease:

Most apartments require a one-year lease. Visit an off-campus rental in-person before signing a lease. Student Legal Services can help you with the process to ensure the lease is legal and appropriate. [sls.colostate.edu](http://sls.colostate.edu).

If you arrive before the assigned move-in date for your program, and *did not* reserve housing prior to arrival, you will need to make temporary arrangements at a hotel or hostel.



# HOUSING AND DINING

## ON-CAMPUS MEAL PLANS

If you live on campus, you automatically get a meal plan and you can choose from one of the following plans. Plans are all-you-care-to-eat including fresh fruit, salad bars, pizza, pasta, deli sandwiches and much more across six dining centers and two express facilities.

- **The Ultimate:** includes virtually unlimited dining with up to 8 meals per day - best if you plan to eat all or most of your meals in the dining centers.
- **Any 19:** includes 19 meals per week - best if you plan to eat two to three meals a day in the dining centers.
- **Any 15:** includes 15 meals per week - best if you plan to eat about two meals a day in the dining centers. This is the default meal plan, but can be changed at any time.
- **Apartment and Off-Campus Meal Plans:** Dining options for students living in apartments or off campus are available. Students who live off campus may purchase meals in blocks of 5.

# REGISTERING FOR CLASSES

## UNDERGRADUATE STUDENTS (NEW AND TRANSFER)

Fully admitted undergraduate students should take the appropriate placement exams, accessible at <http://virtualorientation.colostate.edu/home/to-do-list/44-2/>.

Orientation and Transition Programs at CSU will send you an email with instructions for completing the online Pre-Orientation Module. Once complete, you will be able to register for classes. If you do not sign up for classes before arrival, you will be able to sign up during orientation. If you wait until orientation you may not be able to sign up for desired classes, as they fill quickly.

Transfer students will need to submit more detailed information on previous courses if you wish to use that course credit toward your CSU degree. Learn more about transferring credit at [registrar.colostate.edu/transfer-credit](http://registrar.colostate.edu/transfer-credit).

## GRADUATE STUDENTS

Graduate students should contact their department to receive information about signing up for classes. Each graduate department has different policies about course registration. Contact information for academic departments can be found on the [graduate school website](#).



# TRANSFERRING FROM ANOTHER U.S. SCHOOL

If you are transferring from another school in the United States and already have an F-1 visa, you must complete the [Transfer in Clearance Form](#) as soon as you have been admitted to CSU. If you do not intend to transfer your SEVIS record, please contact CSU to obtain a new I-20 or DS2019 for re-entry purposes. Do not use your previous school's I-20 or DS-2019 to re-enter the United States.

## BRINGING DEPENDENTS

If you are in F-1 status, your spouse or child(ren) under 21 years old may accompany you on an F-2 dependent visa. F-2 visa holders are not allowed to work or pursue a degree program or any other full-time language training program. Additional funding and documentation may need to be provided for your dependents.

If family members accompany you to CSU:

- Living expenses may increase by 50% because of increased housing, transportation, food, and childcare costs.
- CSU does not offer spouse or dependent health insurance plans. Other health insurance options for your family can be found at [connectforhealthco.com](https://connectforhealthco.com). Spouses or domestic partners of eligible students may access the CSU Health Network by paying the student health fee on a semester basis or paying for medical services as they are received.
- F-2 dependents may not work under any circumstances. J-2 dependents may apply for work permission from the USCIS only if the income earned is to be used for support of the spouse or children, not for support of the J-1 student or scholar. # ARRIVAL AT COLORADO STATE UNIVERSITY

## DENVER INTERNATIONAL AIRPORT

Fort Collins is most easily accessed by way of Denver, Colorado, which is an hour south of CSU. This is the most common way for students to arrive in Colorado.

## SHUTTLE SERVICE TO FORT COLLINS

The most economical way to travel between DIA and Fort Collins is to take the [Groome Transportation](#). The service offers rides every day of the week, and drops passengers off at various Fort Collins locations, including major hotels and the CSU campus. For an additional fee, they can drop you off at a specific address. ***Please use discount code "CSU" when making your reservation.***

# WHAT TO PACK

## CLOTHING

Due to weather changes, you will need clothing for both warm and cold seasons. All of these items are available for purchase in Fort Collins upon arrival. Only pack what you will need for the first few months after you arrive.

Eventually it will be very important to have a good winter coat, hat, gloves, and boots.

## ROOM ESSENTIALS AND DECORATIONS

Consider bringing decorations for your room that will remind you of home such as photos, books, music, recipes, and items associated with a hobby or sport you enjoy. Many students also choose to bring items of cultural significance such as their national dress.

## APPLIANCES

U.S. electrical outlets are 110 volts AC and use a NEMA electrical socket. You may need an adaptor to use electronics from home. Appliances with exposed heating elements are prohibited in residence halls. Purchase appliances after you arrive.

## CELL PHONES

If you want a cell phone while living in the U.S., we recommend waiting to purchase the phone until you arrive. You will receive more information at orientation.

## LUGGAGE

Always label all of your luggage clearly. The label should have your full name and the address of International Programs.

## CAMPUS SAFETY TIPS

CSU is a very safe and welcoming place, but is important to follow these steps to help ensure the safety of you and your property.

- Lock your bicycle to bike rack that is secured to the ground whenever you leave it unattended. If you lock your bike to anything other than a bike rack, you can be fined. A U-Lock is recommended for locking your bike.
- Do not leave items unattended in the library, classroom, or cafe.
- Always keep your student ID card with you in a safe place.
- Always lock the doors, and windows in your housing.
- Always lock your car and do not leave valuable items in it.
- Do not keep a lot of cash with you or in your housing.
- Keep your passport and other important documents in a safe, locked location.
- When traveling at night, do so with a friend or in a group.

# MONEY AND BANKING

## CASH

When you arrive in the United States, you should bring at least \$500 in cash to cover immediate needs such as books, a cell phone, and other living expenses. Cash is accepted at most locations.

- One dollar (\$1) is equal to 100 cents.
- Common coins include:
  - Penny (1 cent)
  - Nickel (5 cents)
  - Dime (10 cents)
  - Quarter (25 cents)
- Common paper bill amounts are: \$1, \$5, \$10, \$20, \$50, \$100.



## CREDIT/BANK CARDS

In the United States, the most widely accepted bank and credit cards are Visa and MasterCard. Bank cards can either be debit, which pulls funds directly from your bank account, or credit, which you pay off at the end of each month. Apply for a credit card in your home country before you travel since it may be difficult to get one after you leave.

## BANK ACCOUNTS

It is not recommended to regularly carry large amounts of cash with you, so once you arrive, you will need to open a bank account. To open an account, you will need two pieces of photo identification (your passport and your student ID/Ramcard,) your U.S. mailing address, and money to deposit. During orientation, CSU will give you information about local banks, and can help you open a bank account.

There are two banks located inside the Lory Student Center.

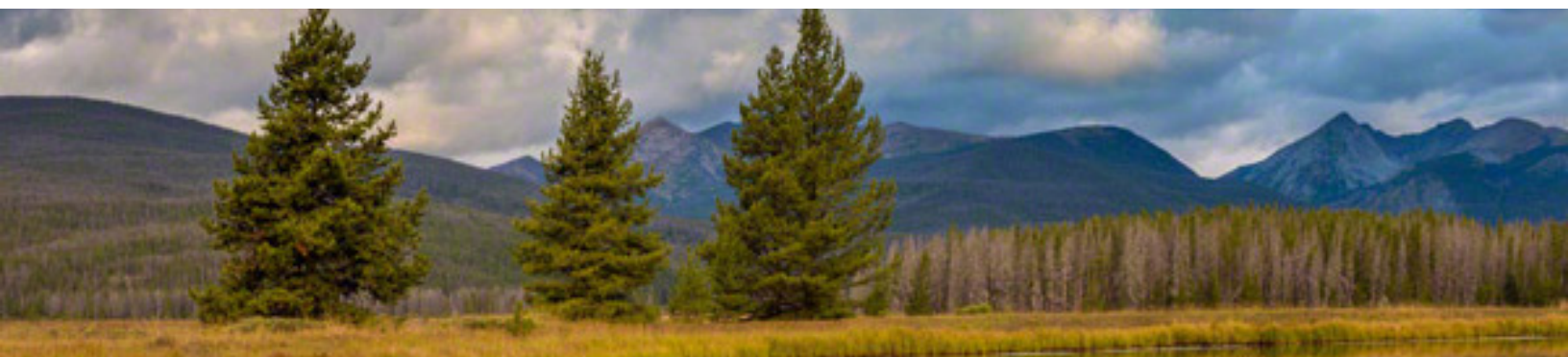

Bustang connects Fort Collins with Denver, Grand Junction, Colorado Springs, and other cities across Colorado.

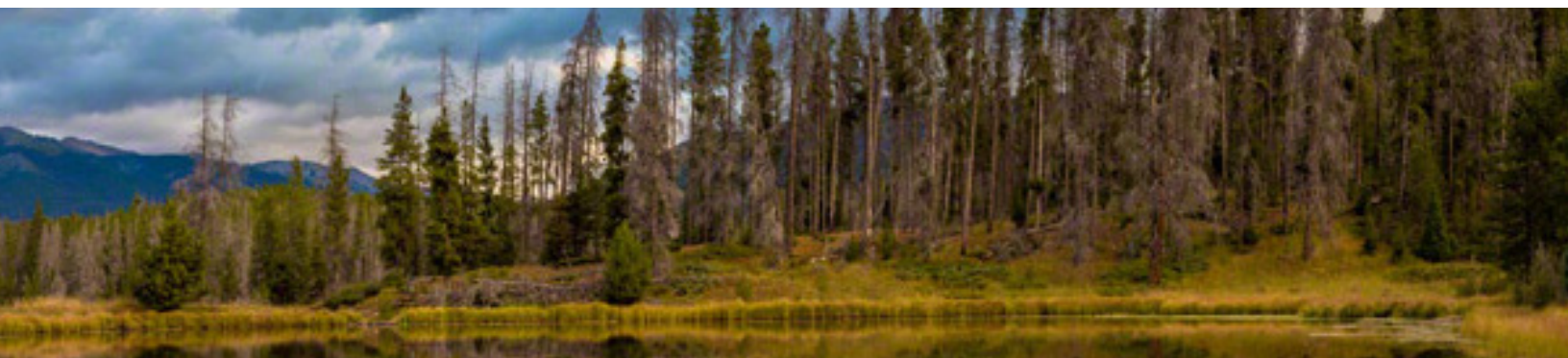
